## MEDICAL CANNABIS PROTEST LONDON WED JUNE 25TH 2008



The medicinal cannabis protest, has the aim to get the government to change the cannabis laws in the UK, so medicinal cannabis users have the right to use cannabis without the fear of prosecution.

On the return of our two TV stars after their debate with a crazy comedian, a sing along got started in a corner, which went down well. Then the petition was delivered by Pinky, Emma, Don and June. After a few more speeches, which were most effective. Pinky started putting letters on peoples bums for the mooning!

This certainly broke the ice even more with everyone, as you got your letters and had to hold onto your clothing strategically so, neither the letters or other parts were exposed, mixed sexes stood and mooned at Downing Street!

# A MEDICAL NECESSITY PROTEST

The pressure to legalise and utilise cannabis does not abate for Prime Minister Brown. As he was whizzed past our sunbathed protest, some 100 medical users congregated from all over England making their feelings perfectly clear.

After the disastrous decision to reclassify cannabis back to class B, against the overwhelming scientific advice of the ACMD and against the majority feeling in the police force in general, not just with Chief Constable Brunstrom, this protest to stop medical marihuana users being prosecuted was almost inevitable.

Those who grow their own, because of large scale cannabis contaminations and no state control over it, and who do so for their own consumption within their private sphere, should not be prosecuted or busted in dawn rates.

Biz Ivol, a prominent campaigner from Orkney, died from stress and harassment by officialdom, Lezley Gibson and Pat Tabram, both very ill and suffering from debilitating diseases, were dragged through the courts and harassed by an unjust law.

Cannabis provides pain relief and relaxation of muscles no other drug can shake a stick at, with no side effects in many.

Compare this to many prescription drugs which cause numerous side effects including: bleeding orifices, eczemas, itchy skin and much more. Frequently, those drugs are the underlying direct cause leading to the death of thousands worldwide, without regress.

As it is such a good stress relief, should not cannabis be decriminalised with a view to legalisation?



# The Legalise Cannabis Alliance - We Don't Believe in Violence

The LCA formed in 1999 as a political party, and over the years stood in many general elections, Howard Marks even stood as a parliamentary candidate. The idea for the LCA was to fight the politics surrounding cannabis by becoming political, and hitting politicians where it hurt, in the ballot box.

We gained support from all corners of the political game and then finally cannabis was reclassified to a C from a B, meaning lesser sentences for cannabis possession and dealing, however the law also brought the banning of smoking in public places, around schools and colleges and worryingly no definition between what was a personal amount of cannabis and what was deemed as dealing.

When the law changed people became comfortable, for many people class C meant cannabis was legal and no matter how much publicity the government put out, it seems more and more people were into cannabis, many believing it now legal.

But politics were becoming complicated; many of our supporters were now concerned by the war in Iraq, petrol prices, education, environmental issues and the future of the country as a whole.

We always raised our own funds for standing a candidate and this was always managed but seemed unfair when bigger mainstream parties had funding and backhanders.

As a single issue party, that finds such a diverse membership decided to put it to a vote to members, should we remain a single issue party with little chance of winning an election? Would anyone wish to develop a bigger campaign covering more issues (with a lot of work required) or become a campaigning group?

The vote saw us decide to de-register as a political party and become a pressure group with the same aims ,and we could welcome people from any political party to join us, as in politics you can only affiliate to one party, and we knew there were staunch labour and conservative members that also believed in legalising cannabis.

In recent months, we have been discussing a court support group to help people charged with cannabis offences, we have began contacting other counties to link our campaigns, we are also forming a campaign Think Tank, and have recently attended Pinkie's Medical Demo in London.

We work with ENCOD and hope to open our campaign up to others who support the legalisation of cannabis.

We are currently discussing holding a meeting for the Think tank, writing to each and every member of the House of Lords to protest the governments decision to reclassify cannabis, and have an on-going questionnaire so we can begin using real results from real cannabis users to fight the law as it stands today.

We support users of cannabis and have our own set of aims and proposals that are the foundations of the group.

The LCA run a membership scheme and the fees help cover the running costs. Membership is just 50p per week or £24 a year. Of course we welcome donations which can be given anonymously.

Members benefit from discounts at many on line and street retailers and receive a membership card and access to our dedicated members forum.

# A ROYAL REQUEST

Our Pride, Your Majesty,

We, the Legalise Cannabis Alliance, represent the interests of those members of the tax paying British public who choose to use cannabis for either medical or recreational purposes.

Cannabis in our society has been around for thousands of years and is part of our culture, just like the monarchy. In fact it is well documented that Queen Victoria used cannabis to ease menstrual pain and discomfort.

The public has however been misinformed and lied to by the government and the British media, leading to potential reclassification of cannabis to the more serious Class B, alongside much more harmful substances such as amphetamine.

The laws against cannabis are being mis-applied, leading to Human Rights violation. This means that the law is causing more harm than good and is punishing those very people it is designed to protect.

The police invade people's homes on a daily basis across the UK for the sole purpose of stopping possession or small scale cultivation of cannabis for personal use. These are often sick people using cannabis for medical reasons.

We propose that adults be allowed to grow cannabis for both medical and recreational use, within their own homes without fear of conviction. We believe this will dramatically reduce the availability of cannabis on the black market and therefore reduce it's availability to children.

Your Majesty, the British people believe You are more than a statue or a tourist attraction and need Your help with protecting our freedom, our choice and our right to self-medicate.

Your Majesty, we hope You hear our cries and would like to invite You to a Medical Cannabis Protest in Parliaments Square on June 25th 2008. These are Your people.

## PROPOSED PROHIBITION OF SEEDS

On Wednesday 9th July Tom Brake MP for Carshalton and Wallington introduced his Ten Minute Rule Bill: Cannabis Seeds (Prohibition) in the House of Commons. The bill is a response to the vast number of concerned constituents who contacted Tom about the shop, 'Your High', which legally trades in drugs paraphernalia and cannabis seeds just around the corner from a local primary school in Wallington.

During the debate Mr Brake said: "My purpose today is simple: to prohibit the sale of cannabis seeds. That minor change to the law would send a major message and ensure consistency between the law on the sale of drugs such as cannabis and the law on the sale of cannabis seeds, which help people to grow their own!"

The bill was opposed by Paul Flynn MP who suggested that it should have considered the use of cannabis for medical purposes. Paul Flynn did not press the bill to a vote. The second reading of the bill is scheduled for Friday 17th October 2008.

Cannabis Campaigners urge MP's to reject prohibition of cannabis seeds bill

In a political U-turn, the Liberal Democrats not-so-liberal drugs legalisation policies on cannabis was thrown into question last week by Tom Brake MP, who split his party in the middle by introducing Bill 136, the Prohibition of Cannabis Seeds Bill.

Ingo Wagenknecht, a spokesman for the Legalise Cannabis Alliance (UK) said: "Such a bill will not only be unenforceable, impractical and an outright waste of taxpayers money to enforce. It will diminish our agricultural choices and introduce a Government-led cartel regime as to what species can be grown. Farmers, just as with GMO's, currently growing hemp for industrial and medicinal purposes under Government license, would have to agree not to sell or save seeds for the next year, a ludicrous suggestion that belies Lib Dem unity on their policies."

He added: "The Hemp genus is far too valuable to us to have it further prohibited, indeed it is criminal to withhold it from society when it could benefit us so much, never mind the drugs that can be won from it.

"Whilst splitting the Lib Dems and self-deluding us into believing that they are tough on drugs, especially at this point in time when we are looking for real alternatives to our oil based economies when we want to cut down on CO2 and want to reduce harm to our youngsters, our future taxpayers and pension providers, this proposal does nothing to forward debate. It perpetuates the same old prohibitive messages that have served to proliferate drugs and keep it in the hands of criminals."

"How can you have a policy wanting to legalise cannabis and then ban the seeds?

"Until this bill 136 falls, we will be advising our members to only vote for candidates that have voiced their support for the equal application of the Human Rights act, the legalisation and control over cannabis and for real harm reduction in society"

"The LCA urges all MP's to deny this bill a second reading on October 17th. It already represents a waste of public funds and time.

"In the two-month leading up to the second reading our members will lobby MP's, we hope to avert this bill before it becomes another unwieldy and useless tool for an overburdened police force and stick in the mud bureaucratic structures that are currently determining drug prohibition and harm on our streets.
















#### What's in a name.....
