# Brainstorming with ENCOD in Basque Country

After a comfortable flight to Bilbao and a bus ride to Vitoria-Gasteiz, I was met on time at the bus station by Joep from ENCOD and a few members of Spanish Cannabis Clubs. We were taken to the small nearby village of Murgia for the three day conference workshop "Drugs and Diplomacy" organised by ENCOD for the CAPV (Autonomous Community of the Basque Country). As well as two "user group" representative from the UK, there were delegates from Italy, the Netherlands, Germany, Belgium and from about 15 Spanish Cannabis Clubs.

Each brain-storming session proved to be educational and lively indeed – everybody with plenty of ideas and a very positive feeling. Before we had started the Spanish cannabis groups had prepared their own recommendations to the CAPV, now it was to be our turn. The issues were the participation of consumers and their associations in drug policies in general and in drug action in particular and the capacities and difficulties of organisations of drug users at the moment of intervening in political debate: in the UK we know how difficult it is to communicate with our own Government on policy issues regarding cannabis.

The first session, on the Friday evening, lasted over five hours! I found the format exciting and encouraging – an excellent way to get people to participate and an example for us all. We discussed our strengths and weaknesses, our opportunities and threats. The ideas that came were far too many to list but a few here.

The main weaknesses were seen as the lack of professionals, money and activists – just like the LCA! (Self)-stigmatisation of users of some drugs is a major problem. More positive, the delegates agreed that we had "truth on our side", that we are "on the streets" at user involvement levels, and have the capacity to work well as a team.

Amongst our opportunities is our ability to conduct research by users into users to break the dominance of government-funded research which could lead to greater communication and crossing of the stigmatisation barriers.

But many people present felt that users are seen as a minority of small fish that make the prohibition system work. Government tries to justify over-riding human rights with risks of harm to users. Users are stigmatised.

Ed Stratton's Human rights case that is pending in the UK, challenging the right of governments to discriminate against users of certain drugs, contrary to Property Rights – if the case is won it may indeed be an end to prosecutions for personal possession and cultivation of cannabis.

Saturday saw another two mammoth ten-hour sessions, with a third on the Sunday, and as you can imagine the details are too many to list here – I will be writing a full report which will be published on our LCA forum in the ENCOD section. For now, let me say it was all highly productive.

The main risks to drug users themselves, apart from the law, were seen as the possible social and life-style consequences, adulteration and contamination, unemployment and homelessness, stigmatisation and marginalisation, and overall invisibility.

The remainder of the time was given to evaluating and building a response and recommendations to the Summary of the Draft EU Drugs Action Plan for 2008-2012. ENCOD will produce a document that will be open for support from everyone, within a few weeks.

Despite the establishment of EU Dialogue Forum, there is a marked absence of users – the opening line of the EU draft says "Drugs are a major concern" – we disagree with that!

ENCOD's idea is to tackle risks and harms, not demand and supply. We need to define responsible use and supply, but also to allow authorities to focus more on vulnerable groups, avoiding intrusive interventions which further alienate users. We need to propose working alternative models such as self-help centres and Cannabis Social Clubs for collective growing.

ENCOD, with the support of member organisations, will submit funding proposals to both the CAPV and the EU, for research, summer schools, training and information services.

One question I was asked as about "normalisation": my reply was that there are said to be over 70 million illegal drug users in Europe and many more that use alcohol, tobacco and caffeine – so drug use IS normal. But that means over 70 million citizens criminalised for the personal choices of recreational substances – and 70 million criminals in Europe is not "normal" by anyone's standards. Clearly something is very wrong here.



## My year in the LCA

I've been a member of the LCA for a year now. And what a year! My reason for joining at that time, was my way of helping the legalisation of cannabis through the small donation of £24 a year with no thought or intention of anything else.

From the start, I was made welcome and soon began to feel part of a large family that I hadn't even met. Visiting the forum became an enjoyable part of my morning routine. As I had been busted the year before (but not charged) I was interested in reading about court cases and Neil Morgan's in particular since he also lived in South Wales.

That led to offering my support to Neil, which was an interesting learning experience. When his trial day came up on the 17th June, I went to Cardiff Crown Court, there I met Jan, Winston, Marley and Neil. It turned out a fabulous day as Neil didn't get sent down but had to return at a later date. We all went back to Neil's for celebrations and so my first friendships had been forged.

I had also been interested in Pinky's protest and petition for the non-prosecution of medicinal cannabis users so, because of Winston's kind offer of accommodation I decided to make the journey to London for the protest on the 25th June. That was an amazing experience for me. I met Pinky, Chris etc. The sun was shining, we had our own little bit of Whitehall opposite Downing Street cordoned off. It all felt very homely, we were allowed to 'medicate' openly so to me it felt very decadent to sit relaxing in the sunshine smoking a spliff in full view of MI5 and the police. When the time came for Pinky to go to Number 10, I crossed the road only to take pictures of him but the policeman at the gate thought I was with them and asked if I had ID which I had so I was allowed in. Wow, never in my wildest dreams did I ever think that I'd be on the doorstep of the Prime Minister. Pinky had a spliff pre-rolled which he took out on the doorstep, I had a lighter ready in my pocket and lit it for him. That was a liberating experience and one I'll never forget, many thanks to Pinky for giving me the chance. I didn't take part in the massive moonie but had fun watching the faces of passers-by.

On the 26th July, I attended the Scottish Socialist Youth cannabis protest meeting in George Square, Glasgow wearing my LCA tee shirt, where I was made welcome by the organisers. I met up with two members of the LCA; Sworruba and Glasgow Hobbitt. Another

superb day with hot sunshine, music and ganja.

Neil had been called to Cardiff Crown Court on 2nd September so I was off to Cardiff again. This time I had the pleasure of meeting norrisnuvo, an extremely nice guy. Chris was there with his ukulele, Jan and Winston (and Marley). Neil was to appear the next day for sentencing so I went back to Cardiff to offer what comfort I could to Neil who was certain that he was going to prison but once more he left the court with me. Neil is still out of prison with a deferred sentence so as far as this year goes... it's been a result.

The 18th October saw me on my travels again, this time to Pinky's Redditch protest. This time I met Dilys, Morrighan, Alun and others. Lucky with the weather again although cold. I so enjoyed the chilled vibe and music. Shame that Jacqui Smith didn't turn up despite Pinky's personally delivered invitation. She could have re-acquainted herself with cannabis. I'm sure Winston would have been happy to let her toke on his bong!

So, my first year as a member of the LCA has been eventful, exciting and fun. I'd recommend membership to everyone as it has been an extremely positive experience. I look forward to 2009 with optimism. Sincere thanks to all I've met for enriching my life. Elfrynstar

# AREGOING TO ARREST US ALL HOME-SECRETARY?

The idea for the campaign slogan came from a post I saw in a Cannabis Lobby thread. The slogan threw down a challenge to the government on behalf of every cannabis user in the country. I had been interviewed by the producer of a forthcoming edition of the BBC Horizon programme who seemed keen to try to present a true picture based on scientific fact and personal experience. I was impressed by her comment that the film was based on science and research and therefore would not have to tow the official BBC line on the subject, which we all know to be biased and censored. It made me angry that we are always represented in the media as kids or scruffy youths in hoodies using 'skunk' as they term it to escape the hardships of their lives and that somehow cannabis turns them into de-motivated, anti social violent thugs. 'We' of course know this to be blatant propaganda and untruth.

The government appears to be unable to separate the very real problems faced by young people today from that of cannabis, and there was a strong feeling that it was time we stood up and showed that cannabis users represent every walk of society, every age group, every trade and profession and that there is no such thing as a typical cannabis user.

"Are you going to arrest us ALL Home Secretary" becomes a potent challenge when placed alongside the long list of demanding jobs that cannabis users do and of the valuable contribution that we all make to society. That and the vast number of sick and disabled people who find that cannabis helps them to cope with pain and daily life presents a powerful focus for our campaign.

What's needed now more than ever is UNITY, for every cannabis user in this country, med user or recreational user to come onboard and support this campaign. Past rivalries must be put aside, we are after all fighting for a common cause.

Please visit the campaign webpage, watch our YouTube campaign video, download and display the posters and leaflets, come and support planned local protest events, hand out the cards, anything you can do to spread the word to as many people as possible. Come and have your say in the forums (linked from the main page), just get involved in any way that you feel that you can. If you cultivate your own cannabis (as an estimated 700,000 people in this country currently do) I can understand your reluctance to get involved in openly campaigning BUT you can still do your bit by getting the message out there, displaying the posters, spreading the word sending the leaflets to your MP etc.

We must ALL push this as hard as we can and make this the most successful pro cannabis campaign ever mounted in this country. If we sit back and continue to accept the situation as it stands then many, many more of us will end up being dragged through the criminal justice system for a so called crime that has no victim. It ruins lives, destroys careers and criminalises otherwise law abiding people. It has to end now!

But if we all stand together as one and unite We could change this law with a bit of a fight The Government are wrong and we are right So pass me a spliff and hand me a light


lets all stand up as midnight bongs on the clock spark up a J and give the world a shock wear a ganja outfit as your fancy dress frock one news year eve lets make it rock


The stump of his pipe he held tight in his teeth,

### Swiss say no to legal cannabis but yes to prescription heroin

The Swiss decided on 3rd December to reject a proposition to decriminalize cannabis for personal consumption, but with a large majority voted to extend a government programme which gives heroin to hard-core addicts. The nationwide referendum saw voters back the government's so-called four pillar drug policy, which promotes prevention, harm reduction, therapy and repression.

### Amsterdam to Shut 43 Cannabis Cafes

Amsterdam is being forced to close 43 of its 228 cannabis-selling cafes to meet national regulations. The establishments, including the world famous Bulldog, are simply too close to highschools.

### Government Ignores Scientific Advice

U.K. Parliament's House of Lords approved the government's proposal to reclassify cannabis as a dangerous Class B drug, along with amphetamines and speed, against the recommendations of its own Advisory Council on the Misuse of Drugs (ACMD).
